



**UNDERTAKING, RELEASE AND WAIVER  
REGARDING MY PARTICIPATION AS DOG TEAM RACER  
IN THE IVAKKAK 2023 DOG TEAM RACE**

(scheduled to start in Kangiqsujuaq March 15th, 2023 and end in Aupaluk (thereafter))

I, the undersigned, do hereby acknowledge as follows:

1. **That** I shall be responsible for my conduct and that of my dogs throughout the Ivakkak 2023 dog team race;
2. **That** I understand and agree to abide by all regulations governing the Ivakkak 2023 dog team race;
3. **That** I recognize the inherent dangers of dogsled racing and am doing so at my own risk;
4. **That**, in consideration of accepting my participation in the Ivakkak 2023 dog team race, I, my heirs, executors, administrators and assigns do hereby release Makivvik Corporation, the Fédération des Coopératives du Nouveau-Québec, the Kativik Regional Government and Northern Village Corporations of Nunavik, and the Landholding Corporations of Nunavik (hereinafter the "Sponsors"), their respective servants, agents or employees from any claims, demands, damages, action or cause of actions arising out of or in consequence of any loss, injury or damage to my person or property, including the dogs themselves, incurred while attending at or participating in the Ivakkak 2023 dog team race, notwithstanding any such loss, injury or damage which have arisen by reason of the negligence of the Sponsors, their servants, agents or employees. Without limiting the generality of the foregoing, I further release any recourse, which I may now or hereafter have resulting from any decision of the Sponsors.

Moreover, I, my heirs, executors, administrators and assigns, agree to indemnify the Sponsors, their servants, agents or employees from any claims or demands which may be made against the Sponsors arising out of or in consequence of my participation in the Ivakkak 2023 dog team race;

5. **That**, in consideration of the free transportation provided by Air Inuit Ltd. for my dogs and equipment, I, my heirs, executors, administrators and assigns do hereby release Air Inuit Ltd. from any claims, demands, damages, action or cause of actions arising out of or in consequence of any loss, injury or damage to my person or property, including the dogs themselves, incurred while the above-mentioned dogs and equipment were being transported by Air Inuit Ltd., notwithstanding any such loss, injury or damage which have arisen by reason of the negligence of Air Inuit Ltd., their servants, agents or employees. Without limiting the generality of the foregoing, I further release any recourse which I may now or hereafter have resulting from any decision of Air Inuit Ltd.

Moreover, I, my heirs, executors, administrators and assigns, agree to indemnify Air Inuit Ltd., their servants, agents or employees from any claims or demands which may be made against Air Inuit Ltd. arising out of or in consequence of the transportation of my dogs and equipment by Air Inuit Ltd;

6. **That** I hereby give my express consent to have images of my person, taken while attending at or participating in the Ivakkak 2023 dog team race, used without any remuneration or compensation by the Ivakkak 2023 Organization and/or by attending Medias for various purposes including advertising, press releases and publicities among others.
